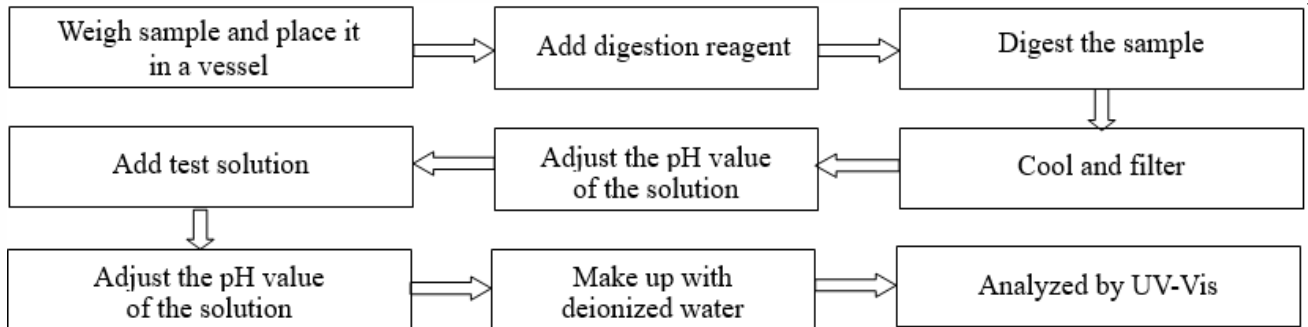

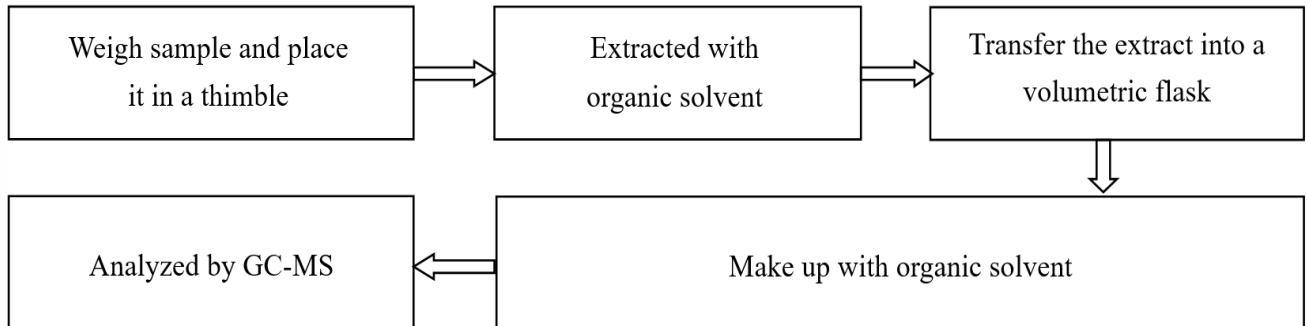
### 2. Mercury (Hg)

### 4. Polybrominated Biphenyls (PBBs), Polybrominated Diphenyl Ethers (PBDEs)

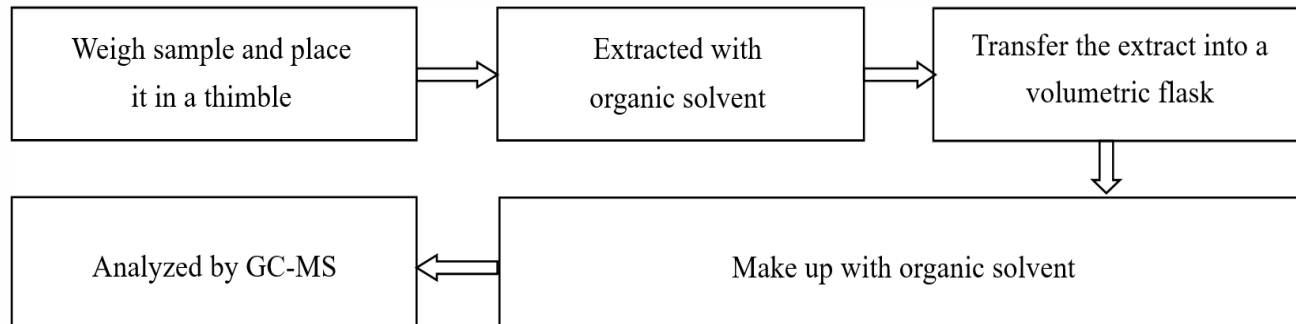

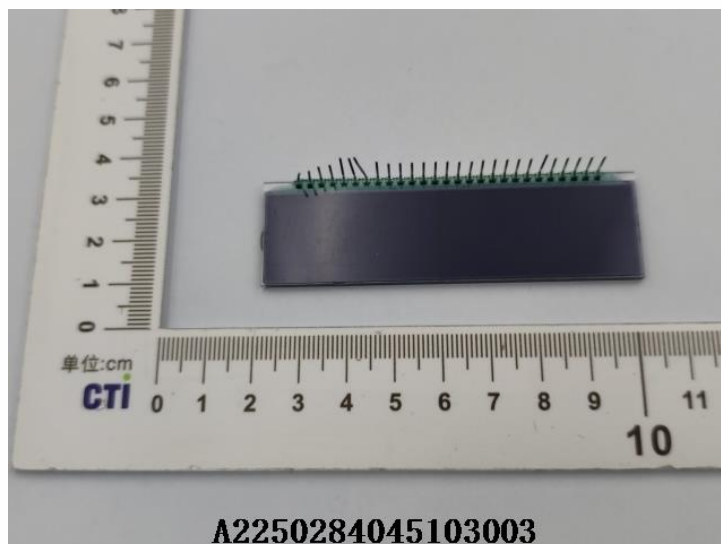
